(f) to promote, support or take over affiliate, amalgamate or merge with any other institution of body having objects wholly or in part similar to those of the Trust.

(g) To raise and borrow money or such security as may be deemed appropriate, to incur other obligations relating to the property of the Trust and similar to lend money with or without security and upon such terms and conditions as the Trust may think for and proper, to pay from the fund of the trust all expenses that may be incurred in raising funds for the Trust, including brokerage and commission.

(h) To open and operate bank accounts, draw, accept, endorse, discount and negotiate, cheques, bills of exchange, promissory notes and other negotiable instruments.

(i) To invest fund of the trust in such share, bonds, certificates, securities, government loans or other investment from time to time as may be deemed necessary or proper.

(j) To institute, conduct defend or compromise legal proceedings by or against the Trust or its employees in regard to any matters affecting the trust indirectly.

(k) To pay out of the funds of the Trust or out of any particular part of such funds all expenses for carrying out any of the for going objects including payment of salaries and payment to persons employed.

(l) to promote or associate with any other persons, authorities or bodies for attainment of the objects herein stated and in that behalf also invest funds of the Trust to the extent and in the manner deemed appropriate.

(m) To extend, vary or amend any of the provisions hereof.

(n) To do all such other lawful thing as are conducive or incidental to the attainment of any of the above objects and for furthering the growth of the Trust or its resources.

4. That the trust shall be named and known as "**SOUTH DINAJPUR EDUCATIONAL WELFARE TRUST**" which will function as a non profit and non political organization and utilize all the recourses generated or received only for the object of the Trust.

5. The income and property of the trust will be applied solely for the promotion of the objects of the Trust, as set forth herein before and also any other thing related to education and no portion thereof shall be paid or transferred directly or indirectly by way of dividends bonuses or otherwise howsoever by way of profit to any person provided that nothing herein contained shall prevent payment in good faith of remuneration of any officers or servants or employees of the trust or other persons in return for any services rendered to the Trust.
